

# EXCESS REDUCTION COVER

## PLEASE READ CAREFULLY

1. THE FULL EXCESS AND BOND WILL BE CHARGED TO YOUR CREDIT CARD ON ARRIVAL
2. IF YOU HAVE AN ACCIDENT YOUR FAULT OR NOT THE FULL EXCESS AMOUNT WILL BE RETAINED UNTIL THE CLAIM IS RESOLVED. YOU WILL ALSO LOSE YOUR BOND OF \$500. CLAIM CAN TAKE UPTO 6 MONTHS TO PROCESS
3. YOU ARE NOT INSURED ON ANY UNSEALED ROADS OTHER THAN THE NATIONAL PARKS

Your **EXCESS** can be **REDUCED** by paying an additional fixed amount. We always advise customer to reduce their **EXCESS** if possible.

## Accident Liability

Accident liability is the maximum cost per accident you are responsible for should there be an accident. This includes damage to the vehicle and third party property. The accident liability that will apply can be reduced by selecting one of the Excess Reduction options listed above.

## Security Bond

The Security Bond is required as a deposit upon the collection of your vehicle and is a full debit on your credit card. The security bond is fully refundable within 7 days of the return of the vehicle in a clean, undamaged condition with an equal amount of fuel when hired.

## Exclusions

There are exclusions to cover. Please refer to clauses 11 of the full Terms and Conditions of Rental for further information. See below for a non inclusive list of exclusions:

<ul style="list-style-type: none"><li>• Any damage caused while the driver is under the influence of alcohol or any drug that affects the ability to drive.</li><li>• Any damage caused by a driver not authorised to drive the vehicle.</li><li>• Tyre damage.</li><li>• Replacement keys.</li><li>• If the vehicle is driven off road including recovery costs.</li></ul>	<ul style="list-style-type: none"><li>• Damage to the Overhead or Underbody of the vehicle.</li><li>• Loss or damage to personal belongings.</li><li>• The Vehicle is driven when a warning light appears or the coolant temperature gauge enters a red zone (High).</li><li>• Damage to the interior of the vehicle.</li><li>• The use of the incorrect fuel type.</li></ul>

## BOOKING A MOTOR SHACK

### Drivers Licence

Any person wanting to drive a Motor Shack must have a full unrestricted drivers licence.

At the time of rental all drivers must be authorised in the Rental Agreement.

The licence of an authorised driver must be:

- A full, open and unrestricted licence
- An International Drivers Licence must be accompanied by an original or current licence
- Any licence not in the English language must be accompanied by an accredited English translation

### Deposit

A deposit of \$500 is required to secure the booking of the vehicle.

**Only Visa and MasterCard are accepted.**
